EXPEDITE FEE: \$150.00 - Application processed within 24 hours (Normal process 3-4 business days)

TRANSFER FEE: \$25.00 - Licensee moves from one office to another

REINSTATEMENT FEES (within one year of severing membership): \$150.00 - Reinstate membership, plus past Quarterly MLS fees unpaid during the period of severed membership
